B. Review of December 10, 2014 Meeting Minutes: Minutes approved

Discussion of ECE at Bromwell in 2015/16

Kindergarten teachers addressed the benefits of ECE at Bromwell (Amy Ford & Tara Hammond)

1. More continuum
2. TS Gold (social emotional cognitive tracking system being phased in by DPS), ECE would help teachers not start from zero as only public school starts this intensive tracking/testing at preschool. Even 20 is better than zero.
3. Would DPS put something else in the ECE/A0 space?
4. Part of ECE is NCLB offering for kids without access to preschool. But has also tried to give kids with disabilities access, always integrated with typical peers.
5. More recently, expansion of ECE via bond mill levy for kids without access.
6. Breakdown of communication makes everyone look incompetent - embarrassing to have the decision made but not communicated.
7. DPS building, DPS decides programming. District in this region is jammed, when there is open space, they would have put something in there - would have been a center based program. ECE is the center that makes sense for our community, and what the teachers/staff would choose.
8. Jody to confirm details with letter to the community including how the choice process will work for kindergarten. Jody will also confirm what the priorities are within the choice process for boundary, staff and sibling.

1. Kids are more comfortable with the online testing than the adults - used to it.

3. Teachers find PARCC and Common Core initiatives are more rigorous. Example: in 2nd grade kids have to cite text to prove what they know rather than relying on background information. Process is challenging but seems to be working.
